

## **Terms and Conditions of Competition** **Women's Health Australia Main Prize Draw 2**

1. The University of Newcastle, through the Australian Longitudinal Study on Women's Health (ALSWH) (**Promoter**), is conducting a promotional competition (**Competition**) subject to the agreed terms and conditions set out in this document.
2. The Competition is free to enter and commences at 10am (AEST) on **Monday 26<sup>th</sup> June 2023** and closes at 5pm (AEST) on **Sunday 29<sup>th</sup> October 2023 (Competition Period)**.
3. The Competition is open to Women's Health Australia participants, born 1989-95, who complete and submit the seventh Main Women's Health Australia (WHA) survey conducted by the Promoter (**Entrants**). The competition does not involve a round in which Entrants are eliminated.

**Note:** This Competition is one of three separate Competitions conducted for the Entrants outlined in Clause 3. For the terms and conditions relating to the other Competitions, visit <https://alswh.org.au/for-participants/cohorts/1989-95-cohort/>.

4. The Prize pool consists of five (5) \$100 Prezzy Smart eGift Cards with a maximum total prize pool value of \$500.00 (**Prize**).
5. Employees of the Promoter and known members of their immediate families are not eligible to enter.
6. Each Entrant is entitled to one entry to the Prize draw per individual survey submitted during the Competition Period.

The use of any automated entry software or any other mechanical or electronic means that allows an Entrant to automatically enter repeatedly is prohibited and will render all entries submitted by that Entrant invalid.

7. The Prize draw will take place at 10am (AEST) on **Wednesday 1<sup>st</sup> November 2023** at the Hunter Medical Research Institute, Lot 1 Kookaburra Circuit, New Lambton Heights NSW 2305, Australia.
8. The Prize is subject to the following conditions:
  - 8.1. Other than as provided for in these terms and conditions, the winner will be solely responsible for any other costs in connection with the Prize;
  - 8.2. Entrants must provide accurate personal details;

**Note:** Personal details will remain confidential; accessible only to employees of the Promoter who have the appropriate jurisdiction. Entrants' details will be stored securely and protected as per standard study protocol, disclosed only to third parties associated with study management and data linkage, unless disclosure is required by law in order for us to comply with our regulatory obligations. Entrants' details will be retained securely by the University of Newcastle for the duration of ALSWH. All correspondence with the Entrant using the personal details of the Entrant will be conducted by the Promoter and no other party.

- 8.4. Entrants must ensure their entry is received within the Competition Period;

Entries which do not comply with these terms and conditions will not be eligible for the Competition or to win any Prize.

9. No responsibility is accepted by the Promoter for late, lost, or misdirected entries due to computer error or for any other reason. Incomplete, indecipherable entries will be deemed invalid.

10. The prize will be drawn using a randomized manual draw containing one entry for each survey completed by each individual Entrant.
11. The Prize draw will be conducted in the presence of, and scrutinised by, an independent person.
12. The Promoter will make every reasonable effort to notify and deliver the Prize to the Prize winner personally via email within 2 working days of the Prize draw, using the email address provided by the Entrant.
13. The winning Entrants' ID number and first name will be displayed on the ALSWH website (<https://alswh.org.au/for-participants/cohorts/1989-95-cohort/>) by 10am (AEST) on **Friday 3<sup>rd</sup> November 2023** (two days after the Prize draw).
14. If the Prize is unable to be delivered using the email address provided by the Entrant, the Promoter will make every reasonable effort to contact the Prize winner and obtain a nominated alternative email address. The Promoter will make every reasonable effort to arrange for delivery of the Prize to the winning Entrant within 28 days after the Prize is drawn.
15. If the Prize is:
  - 15.1. Forfeited through ineligibility; or
  - 15.2. The Prize is unable to be delivered and the winner is unable to be contacted;three months after the day the winner is notified, subject to any directions from a regulatory (or other appropriate) authority, the Promoter will draw another winner for the Prize in the same manner set out in these terms and conditions, or the Prize shall be dealt with as the regulatory (or other appropriate) authority directs.
16. Subject to Clause 15, the second-chance draw will occur at the Hunter Medical Research Institute, Lot 1 Kookaburra Circuit, New Lambton Heights NSW 2305, Australia, at 10am (AEDT) on **Thursday 1st February 2024**.
17. The Prize is not redeemable for cash and is not transferable.
18. The Promoter's decision in relation to each and every aspect of the Competition is final and binding on each person who enters. No correspondence will be entered into.
19. Each Entrant understands that by entering in the Competition, the Promoter will be collecting their personal information, for the purposes of this Competition and survey participation.
20. All personal information of Entrants will be retained securely by the University of Newcastle under the supervision of staff of the Australian Longitudinal Study on Women's Health (ALSWH). By participating in the promotion and submitting an entry, each Entrant is deemed to accept the terms and conditions of this Competition and each Entrant indemnifies the Promoter against loss or damage it may suffer or any claims against it in connection with any breach of these terms and conditions by that Entrant.
23. If this Competition is interfered with in any way, or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:
  - 23.1. To disqualify any Entrant, or
  - 23.2. Subject to any written directions from a regulatory (or other appropriate) authority to modify, suspend, terminate, or cancel the Competition, as appropriate.

The Promoter is not responsible for any incorrect or inaccurate information, whether caused by equipment or programming associated with or utilised in this Competition, or by any technical error which may occur in the course of the administration of this Competition. The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, computer viruses, bugs, unauthorised intervention, fraud, technical failures, theft or destruction or unauthorised access to or alteration of entries.
